Conference Theme:

### **“The Maritime Cultural Landscape of the Austronesian Diaspora”**

The Asia-Pacific Conference on Underwater Cultural Heritage (APConf) aims to address management and protection strategies of underwater cultural heritage in Asia and the countries of the Indian and Pacific Oceans in the 21st Century, facilitate regional cooperation through the development of academic, non-governmental organisations (NGO) and governmental networks in the Asia-Pacific region, and provide a forum for discussion of technical and ethical issues related to underwater cultural heritage and underwater archaeology

A wide range of people involved with underwater cultural heritage are encouraged to attend including those from universities, government agencies, museums, NGOs, IGOs, the private sector and the community. This conference follows the successes of the Inaugural Asian Academy for Heritage Management Asia-Pacific Regional Conference hosted by the National Museum of the Philippines in November of 2011, the 2<sup>nd</sup> Regional Conference hosted by the National Marine Sanctuary Foundation and the University of Hawaii Marine Option Program, and the 3<sup>rd</sup> Regional Conference hosted by the Hong Kong Maritime Museum.

### **Sub-themes and Sessions:**

Sub-themes can encompass ‘large-scale’ issues in underwater cultural heritage and consist of one or more Sessions. Themes can run over any portion of one day, up to one full day,

depending upon the popularity of that Theme. Theme organizers will be required to draft a suitable description of approximately 300 words which will appear on the conference website. They will be responsible for the overall coordination of their theme within the conference program including recruitment, evaluation, and selection of sessions and organizers. Theme organizers will be expected to chair a session within their theme and be prepared to stand in as chair of a session if required. Theme organizers will be expected to play a role in the conference proceedings publication.

Sessions will address a significant issue or 'sub-theme' in underwater cultural heritage. Sessions may be part of a larger theme, or may be submitted as 'stand alone.' A session will consist at a minimum of three-to-four presentations, each 20 minutes, followed by 20 minutes at the end for questions and discussion. Session organizers are to provide a suitable session abstract of approximately 300 words to appear on the conference website. They will be responsible for coordinating their session within the conference program including recruitment, evaluation and selection of presenters. Individual abstracts and papers will be compiled by the session organizer for submission to the publications committee. Session organizers will be expected to play a role in the conference proceedings publication.

The conference organizing committee can help interested individuals make contact with other potentially suitable organizers or presenters. Theme and session organizers will be expected to attend the conference in person and to present an individual, or jointly written, paper in their own or another theme or session.
